CONDITIONS

1. This Licence is issued in accordance with and subject to the Act and the Regulations, and shall remain valid for the duration of the Licence, unless suspended or revoked by the Minister, in accordance with section 19 of the *Telecommunications Act, 2001-36*.
2. Applicant should use the form "Application for Cyber Café Registration" TU051, available from the Chief Telecommunications Officer.
3. An application fee of \$300 is payable for each location. No Annual license fee is payable.
4. The Licensee and all the persons operating the Cyber Café which the Licensee is authorised by the Licence to establish, install and operate, shall observe and comply with the Act, and the conditions of this Licence.
5. The Licensee shall not permit or cause any unauthorized person to operate the Cyber Café or have access to the Cyber Cafés and equipment installed therein. The Licensee shall ensure that persons authorized to operate the Stations observe the conditions of the Licence at all times.
6. The Licensee shall permit or ensure that permission is granted to an authorized person of the Ministry upon production of proof of identity, to enter any building, premises, compound or other place where the Cyber Café equipment is installed or is being installed, to enable the said authorized person to inspect, examine or test any equipment installed in the Cyber Café.
7. The equipment installed in the Cyber Café shall be designed, constructed, maintained or used such a way that the Cyber Café, when used, complies with the Act and does not cause interference to any other licensed or authorized stations or networks or telecommunication installation or equipment which may be lawfully owned, used or operated by any other person. The Licensee shall permit an authorized officer of the Ministry to inspect the equipment installed in the Cyber Café in order to determine whether the interference is, in fact caused by the said equipment.
8. The Licensee shall notify the Ministry of any intended change of address of the Licensee or any proposed change in any of the equipment installed in the Cyber Café or usage, the location at which the Cyber Café operates, and before such change is effected, the Licensee shall obtain the prior written approval of the Ministry.
9. The Licensee and persons authorized by the licensee to operate the Cyber Café shall not offer, authorize or allow Voice over the Internet (VOIP) services until the start of Phase III of the Telecommunications Liberalisation Program.
10. The Licensee and persons authorized by the Licensee to operate the Cyber Café shall ensure that the Cyber Café and the equipment installed therein are not used for unlawful purposes or misused in any way.
11. The Cyber Café and its Licence shall be available for inspection at all reasonable times by any duly authorized officer of the Ministry.
12. When the Licensee ceases to operate the Cyber Café or where this Licence ceases to be valid, the Licensee shall return the licence to the Ministry for cancellation.

13. The Licence Application Fee shall be paid in advance and shall not be refundable.
14. This Licence is not transferable except with the prior written approval of the Ministry.
15. The Licensee shall comply with any directions or notifications which the Ministry may, from time to time, issue.
16. The Licensee shall inform the Ministry of all rates charged for the services provided at the Cyber Café.
17. The Licensee hereby confirms that the information and documents furnished and supplied for the purposes of applying for this Licence are true and accurate.
18. Interpretation
“Cyber Café” means a premise where persons can purchase Internet access.
