**Telecommunications Act**

**TELECOMMUNICATIONS (REGULATED SERVICES)**  
**ORDER, 2006**

The Minister in exercise of the powers conferred on him by section 4(2)(e) and 110 of the *Telecommunications Act* makes the following Order:

1. This Order may be cited as the *Telecommunications (Regulated Services) Order, 2006*.
2. The telecommunications services set out in the *Schedule* are hereby determined to be subject to regulation. Schedule.
3. This Order applies to
  - (a) any telecommunications service which is related or incidental to the services specified in the *Schedule*; Schedule.
  - (b) the telecommunications services specified in the *Schedule* whether or not those services are offered in combination with other services.
4. This Order does not apply to a non-dominant carrier.
5. The *Telecommunications (Regulated Services) Order, 2003* is revoked. S.I. 2003  
No. 108.

SCHEDULE - *Cont'd***3. Services in Respect of Interconnection Charges**

For the purpose of this Schedule, "interconnection" means the linking of a public telecommunications network to allow users of one licensed carrier to communicate with users of another licensed carrier.

Charges apply to:

- (a) those in any Reference Interconnection Officer (RIO) and any Interconnection Agreements;
- (b) domestic fixed wholesale voice services including fixed termination, fixed origination and fixed joining links of the dominant carrier;
- (c) international wholesale services of dominant carriers;
- (d) mobile wholesale interconnection charges including call termination and call origination charges of all carriers; and
- (e) other mobile services which include at this time:
  - (i) Public Switched Telephone Network (PSTN) Transmit Services;
  - (ii) Special Access Services.

**4. Leased Circuits**

- (a) direct exchange lines;
- (b) domestic leased circuits;
- (c) international leased circuits;
- (d) leased circuits - including all domestic and international leased circuits of the dominant carrier. Dedicated lines for use by a specific customer such as internet leased circuits and international private leased circuits.

**5. International Simple Resale**

International Simple Resale including international voice minutes purchased from any holder of Barbados International Network and Service Provider Licences for switchless resale.

The reseller must hold a valid Value Added (Individual) Licence for International Simple Resale.
